

**“National Pet Month 2026” Sweepstakes
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF MONEY WILL NOT IMPROVE THE CHANCES OF WINNING.

The “National Pet Month 2026” Sweepstakes (the “Sweepstakes”) is intended for legal residents of the United States of America (“USA”) and shall only be construed and evaluated according to USA law and applicable state law. Do not enter this Sweepstakes if you are not located in the USA or are otherwise ineligible to enter in accordance with these Official Rules at the time of entry.

SPONSOR/ADMINISTRATOR: The Sweepstakes is sponsored by Freudenberg Residential Filtration Technologies Inc., 3440 Industrial Drive, Durham, NC 27704 (the “Sponsor”) and administered by American Sweepstakes & Promotion Co. 300 State St. Suite 402 Rochester, NY 14614 (the “Administrator”).

At the Website, eligible Entrants can enter the Sweepstakes by completing the registration form which will request each Entrant’s full name, phone number, and email address. Entrants will then be asked to upload a photo of their pet along with a description of the photo. NOTE: PHOTOS AND PHOTO DESCRIPTIONS WILL NOT BE JUDGED OR GRADED IN ANY WAY. HOWEVER, PROPER PHOTO SUBMISSION WITH DESCRIPTION,

IN THE SPONSOR'S SOLE DISCRETION, IS A MANDATORY STEP OF ENTRY. Each completed Sweepstakes registration form and photo submission (with description) will result in one (1) Sweepstakes Entry ("Entry"). **Limit one (1) Entry per Entrant.**

Proof of Entry information at the Website is not considered proof of delivery to or receipt by Sponsor of an Entry. Entries made by any other individual or any entity, and/or originating at any other website or email address, including, but not limited to, commercial Sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. VOTING, DRAWING, AND NOTIFICATION: During the Sweepstakes Period, submissions will be voted on by the public to determine the following pool of finalists: top one hundred (100) overall submissions receiving votes, top fifty (50) submissions receiving votes for dogs, and top fifty (50) submissions receiving votes for cats. A potential Prize Winner (“Winner” or “Winners”) will be selected in a random drawing for each pool of finalists. Each Prize drawing will be conducted on or about June 15, 2026, by the Administrator, whose decisions are final and binding. The headings herein are for convenience only, do not constitute a part of these Official Rules, and shall not be deemed to limit or affect any of the provisions hereof.
